1. Nominations

I. All nominations to be received by midnight Victorian local time, on the Sunday night prior to race meeting via VSDA online nomination page, payment of nomination fee required to complete nomination.

2. Nomination Fees

- I. All events will have a nomination fee
- II. Nomination Fee structure
 - i. \$30 Southern Speedcar Tour and stand alone events
 - ii. \$50 Victorian Championship and Beasley Family Memorial
 - iii. VSDA nomination fee is exclusive of Sticky Ticket processing fee
- III. Nomination Fee payable at time of nomination
- IV. Nomination fees are non-refundable
 - i. Except where an event is cancelled prior to any competition taking place
 *less Sticky Ticket processing fees

3. Late Nominations

- I. Competitor may choose the penalty
 - i. ROF in heats Regular nomination fee still applies
 - ii. \$100 fee
- II. No penalty will apply if competitor is nominated for any other event (scheduled for the same date), that is cancelled for any reason. Nomination not complete until payment received.
 - i. Nominating for 2 events on same night is not permitted, as per Speedway Australia rules 2.1.2 and 2.1.3.
- III. Late nominations required to phone 0433053426 for manual processing

4. Event Cancellations

- I. The track or VSDA committee reserve the right cancel an event for any reason
- II. Cancellations during events
 - i. Amains declared short as per Speedcars Australia section 4.2
 - ii. 25 points will be allocated to all competitors should an event be cancelled after the event has started but prior all heat races being completed.
 - iii. Regular heat points will be allocated should an event be cancelled after all heat races have been completed but prior to the commencement of the Amain.
 - iv. Prize money payouts of cancelled events other than 4.II.i will be determined by the committee

5. Format

- I. Format for all VSDA events unless otherwise advised
 - i. Two heat races per competitor
 - i. Grids determined by random draw & inversion
 - ii. Grids will be drawn by electronic randomiser and advised on race day
 - ii. B-main if required
 - iii. A-main grid determined by heat points accumulation highest to pole, followed in descending order
- II. Track may request, in consultation with committee, chief steward and race secretary changes to format including
 - i. Time trials
 - ii. Shoot out
 - iii. Extra round of heats
 - iv. Inverted Amain grid

- III. Additional heats will carry normal points
- IV. Additional time trials may carry points or determine heat grids
- V. Pole shuffles and shoot outs may alter Amain grid
- VI. Tied points will be sorted as follows
 - i. Fastest time from heats, as per transponder results
 - ii. Coin toss, where transponder results are not available

6. Drivers Briefings

- I. Attendance
 - i. Drivers briefing is compulsory
- II. Log book
 - i. To be presented upon car inspection and will be held for the duration of the event
 - ii. It is owner/driver responsibility to collect log book at the end of racing

7. Transponders

I. All VSDA events will be transponder events, unless notified otherwise

8. Prize Money

- I. Prize money is subject to change and will be advised as soon as practical
- II. To be eligible for prize money, at least one green flag lap needs to be taken, including hot laps
- III. Prizemoney Structure
 - i. Prize money payable on Amain results only, unless notified otherwise
 - ii. Minimum standard for all events, excluding blue ribbon events
